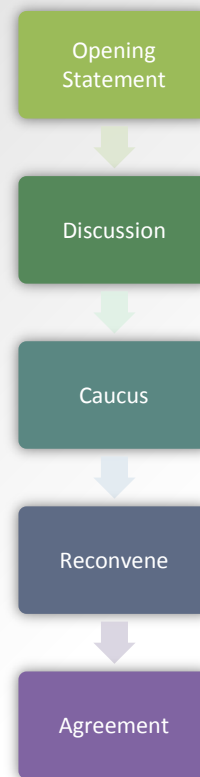

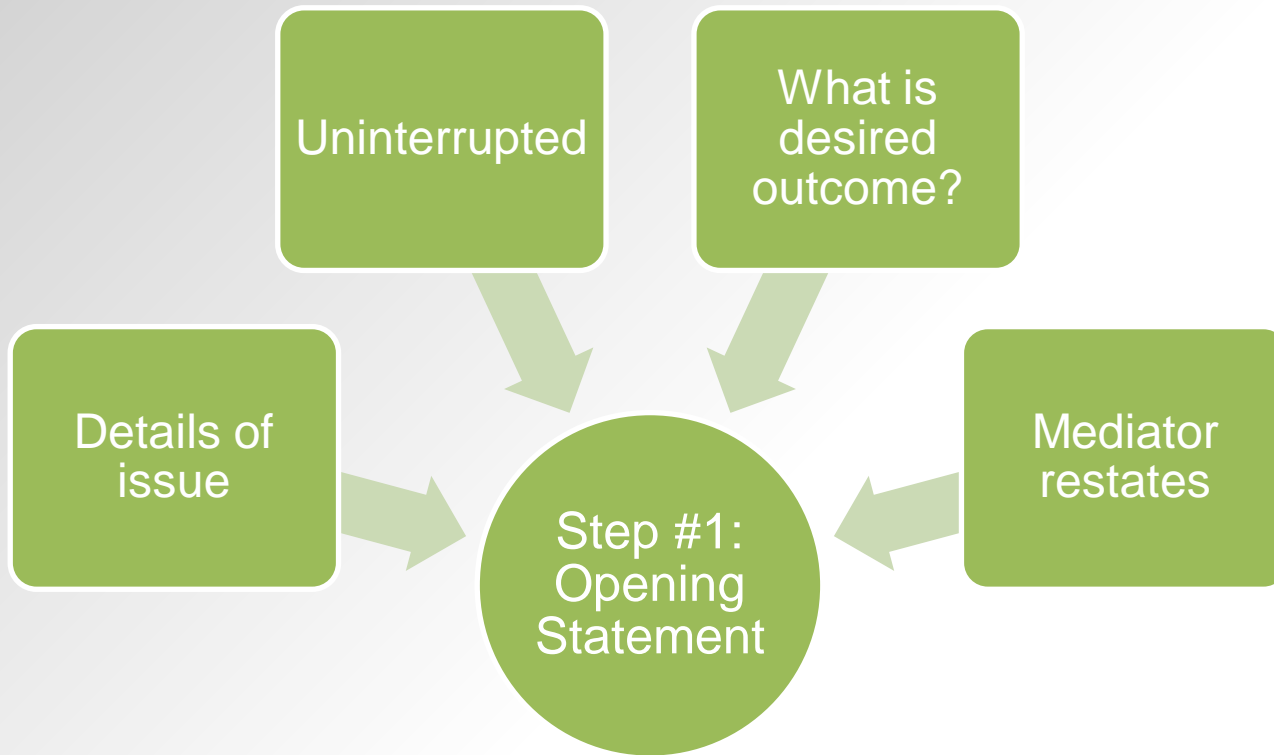

Observer – Provides Feedback

Listener – Restates Facts and Acknowledges Emotions



Listener - use phrases like:

**“What I hear you saying is...”**,

**“It seems like you’re feeling pretty...”**

**“You appear to be saying/feeling/wanting/hearing...”**



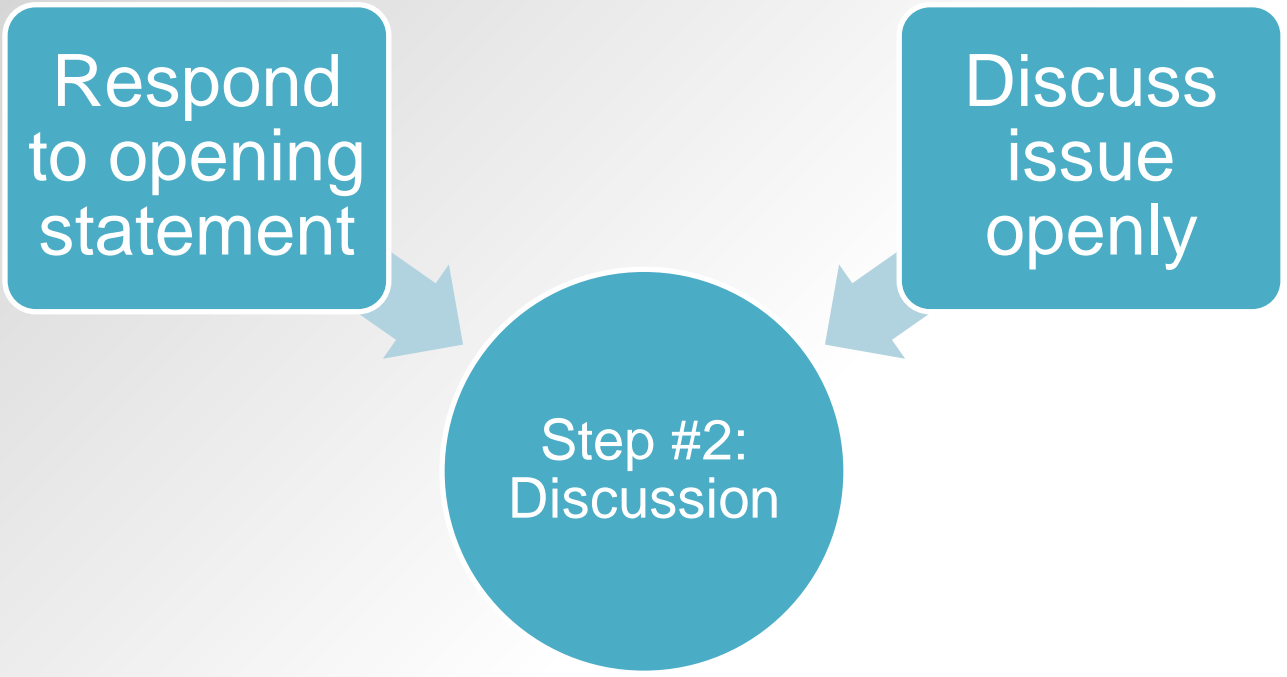
Observer – did the listener:

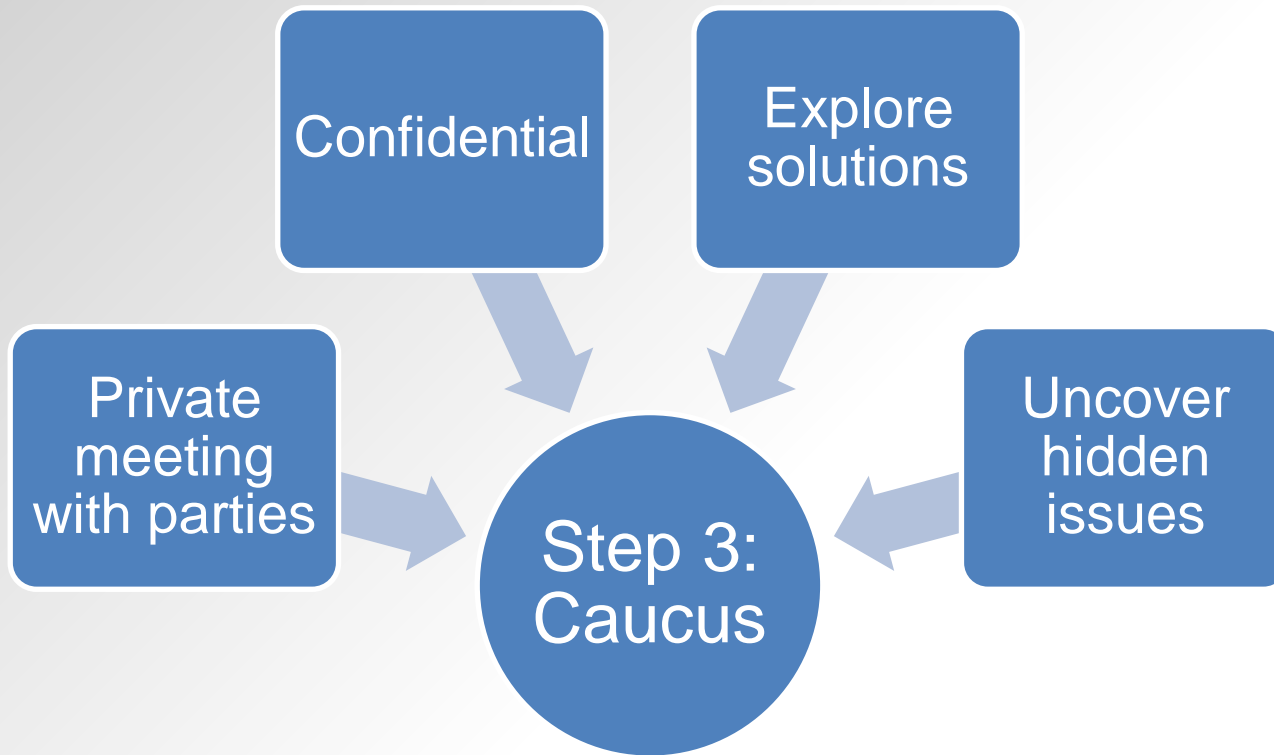
**Restate facts?**

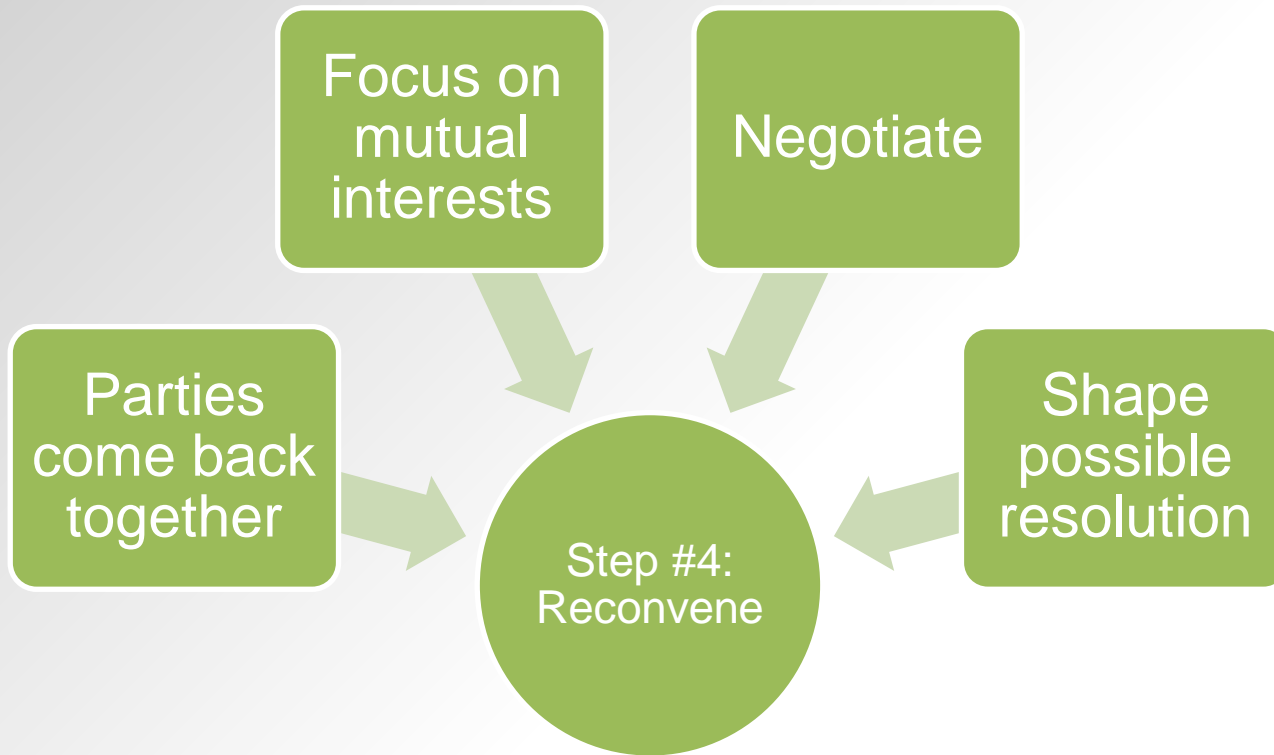
**Acknowledge emotions?**

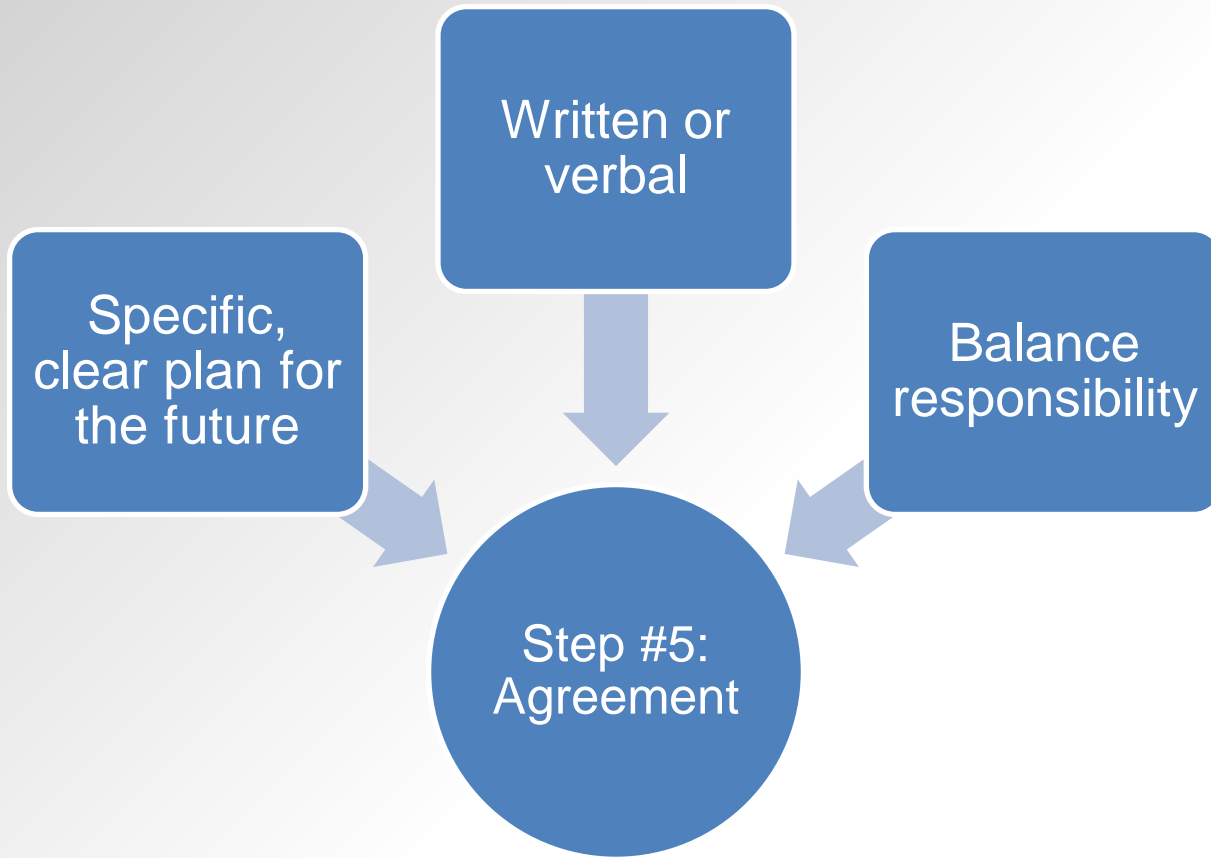
**Ask clarifying questions if necessary?**









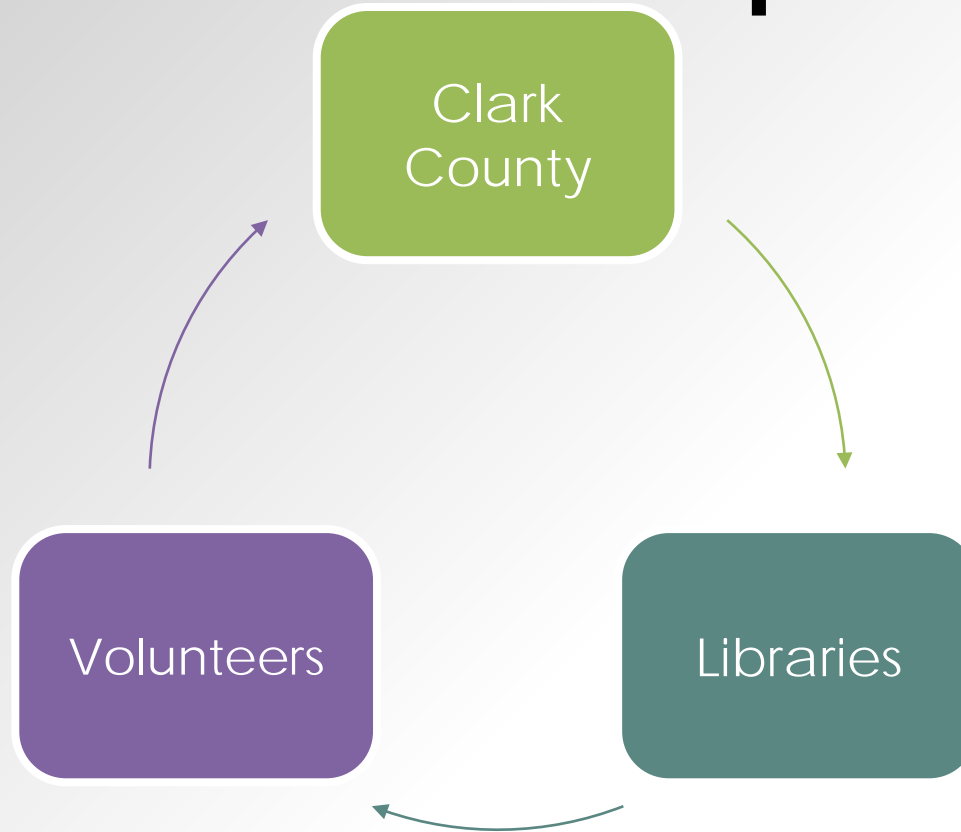

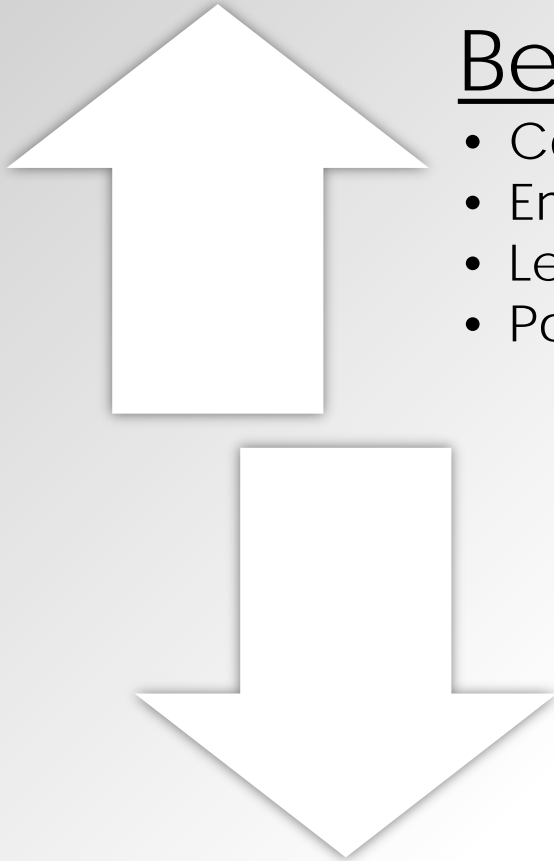
- Increasing number of community disputes

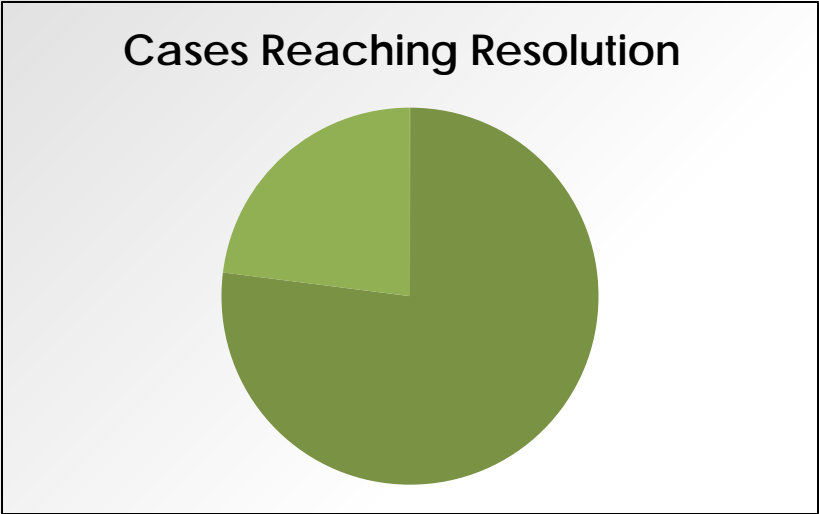
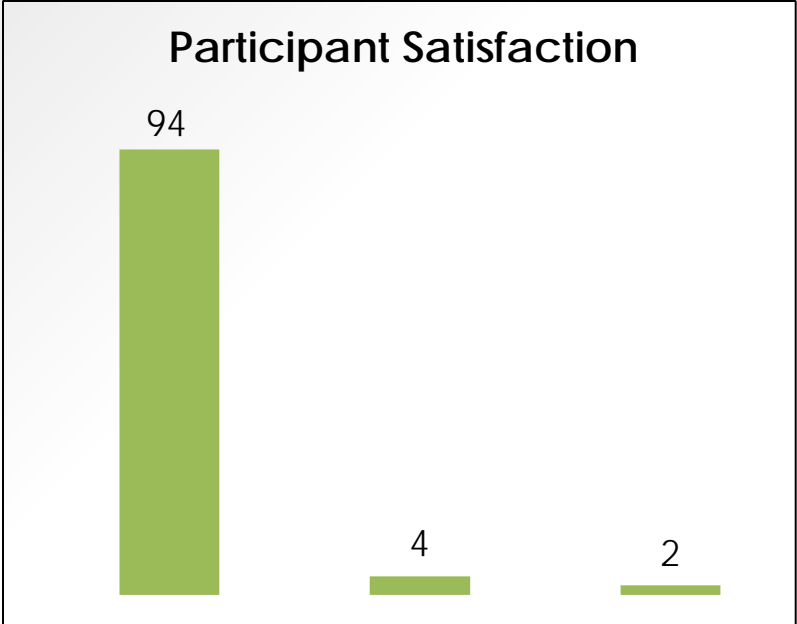
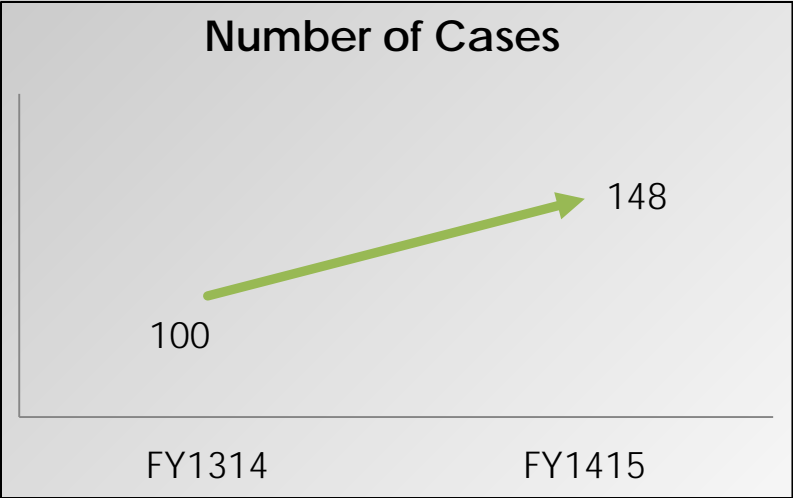
